

HANDSONCODE NON-COMMERCIAL LICENSE AGREEMENT

1. Copyright notice

2. Copyright license

2.1. **Grant of License.** Subject to the terms and conditions of this license, the rights holder identified in Section 1 above (“**Licensor**”) grants you a worldwide, non-exclusive, no-charge, royalty-free, and irrevocable copyright license to use, copy, and modify the Licensor’s software products “HyperFormula” and “Handsontable” (each and collectively, the “**Software**”) and to prepare derivative works based on the Software (the “**Derivative Works**”) (the Software and Derivative Works, collectively, the “**Deliverables**”). The scope and duration of this license are defined in Section 2.2.

2.2. **Permitted Use.** (a) Non-commercial use: You may use the Deliverables for strictly non-commercial purposes, including education, research, study, personal use, testing, and demonstration, provided such use is carried out without any commercial purpose or advantage. The license for such non-commercial use is perpetual. Internal sharing of Deliverables is permitted only to the extent necessary for these purposes.

(b) Commercial evaluation: In commercial or institutional environments (including business entities, professional practices, governmental and intergovernmental entities), you may use the Deliverables only for the internal purpose of evaluating their functionality and suitability in non-production settings, and only for a single, non-renewable period of ninety (90) consecutive calendar days (the “**Evaluation Period**”). The contents of the notice file are for informational purposes only and do not modify this license.
